- 7. (i) You will be paid hasic pay of Rs. 2,200/-per month in the scale indicated above. You will also be entitled to Dearmonn Allowance, House Rent Allowance and C.L.A. at the rates prescribed by the State Government from time to time. In case you are appointed for apperiod of more than one year, you shall earn annual increment.

You shall submit the originals as well as certified true copies of relevant testimonials such as birth date certificate, marksheets, experience certificate, discharge/relieving certificate, last May Certificate, Caste certificate, change of name certificate (if any), etc. before joining your duties.
- 7. In case you accept the appointment you shall have to execute Deed of Contract of Service as prescribed in the statutes at the time of joining the duties.
- 8. You will be allowed to join the duties on preducing of :-
 - (i) Two passport size photographs,
 - (ii) Character Certificate from two eminent persons, one of them should be a Govt. Gazetted Officer.
 - (iii) Discharge Certificate from previous employer (if any).
