3. **Mandatory Course: SEM II: Financial Analysis and Control, Business Tax Assessment and Planning**

Following decisions were taken by the BOS Members -

1. For the Elective Course-Advanced Accounting - Inclusion of relevant Ind AS, Accounting for financial Instruments.
2. For the Mandatory Course – Income Tax- reiteration of including income tax procedures and appeals.
3. For the Mandatory Course – Management Accounting- MIS Report format and Case study on MIS
4. For the Elective Course- Financial Management- Introduction of Exchange rates in the syllabus
5. For Elective Course – Specialised Areas in Accounting- Accounting for Revenue contracts and industry specific challenges in accounting was proposed to make the subject more practical and skill based.
6. For the Mandatory Course- Financial Analysis and Control- New Unit on Financial Planning and Analysis for Individuals was introduced.
7. For the Mandatory Course- Business Tax assessment and Planning- New unit on Tax Planning is introduced, Assessment of Cooperative Societies and procedure for assessment is incorporated.
